### FIREWORKS NEW YEARS DAY

#### Temporary docking and access restrictions

**Start :** 01/01/2024 – 14:00 hrs

**End :** 01/01/2024 – 23:30 hrs

The Collectivity of Saint-Martin is organizing a firework display on the Marigot waterfront on Monday, January 1, 2024, at 9:00 PM. One of the firing points is located on the breakwater of Marina Fort-Louis - [see security map](#). The company SKY FALL PYROTECHNICS will be utilizing a product suitable for close-range firing, requiring a safety distance of 8 meters.

For safety reasons, the following measures will be in effect on January 1, 2024:

- **Navigation restrictions in the port: 8:45 PM to 9:15 PM**, navigation will be strictly prohibited in the access channel and entrance of the marina, no vessels will be allowed to enter or exit the marina during this time. Vessels will observe at all times a minimum 8-meter safety from the restricted area on the breakwater's "DOCK H".
- **Docking restrictions: 2:00 PM to 9:30 PM**, docking and mooring of all vessels, yacht tenders, dinghies or any other floating devices will be temporarily prohibited on the breakwater's "DOCK H".
- **Pedestrian access restrictions: 2:00 PM to 9:30 PM**, access will be strictly prohibited for pedestrians beyond the level of the safety barriers placed before the roundabout of the breakwater roundabout.
- **Vehicular traffic: 2:00 PM to 11:30 PM**, utility vehicles of the company SKY FALL PYROTECHNICS will be allowed to circulate on the breakwater for the show and setup/disassembly of their equipment.
- **It is reminded that vehicular traffic on the breakwater is prohibited**, except for vehicles authorized by the Harbor Master's Office, emergency service vehicles, or police vehicles.
- The entrance of the breakwater should remain clear of vehicles at all times. Unauthorized parked vehicles will be towed at owners' expense.
